Dear Mr. Knight:

The purpose of this letter is to inform you of the steps that I will take to avoid any actual or apparent conflicts of interest in the event that I am confirmed for the position of Assistant Secretary for International Economics and Development.

As required by 18 U.S.C. § 208(a), I will not participate personally and substantially in any particular matter that has a direct and predictable effect on my financial interests or those of any person whose interests are imputed to me, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1), or qualify for a regulatory exemption, pursuant to 18 U.S.C. § 208(b)(2). I understand that the interests of the following persons are imputed to me: any spouse or minor child of mine; any general partner of a partnership in which I am a limited or general partner; any organization in which I serve as officer, director, trustee, general partner or employee; and any person or organization with which I am negotiating or have an arrangement concerning prospective employment.

Upon confirmation, I will resign from my position as Deputy Director of the Research Department with the International Monetary Fund (IMF). For one year after my resignation, I will have a "covered relationship" under 5 C.F.R. § 2635.502 with the IMF. You have advised me that I will receive an authorization under 5 C.F.R. § 2635.502(d) to participate in certain particular matters involving specific matters in which the IMF is a party or represents a party. You also have advised me that I will receive a waiver of the provisions of Paragraph 2 of the Ethics Pledge under Executive Order 13490 with regard to the IMF.

Pursuant to IMF's General Administrative Orders [REDACTED] upon resignation, the IMF will pay me a separation grant of approximately \$180,000 and a payment in lieu of accumulated annual leave of approximately \$70,000. Until I have received these payments, I will not participate personally and substantially in any particular matter that has a direct and predictable effect on the ability or willingness of the IMF, to make these payments to me, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1).
