being an officer or employee of the United States or of any department or agency thereof, did knowingly and wrongfully convert to his own use the property of another which came into his possession or under his control in the execution of such office or employment, by failing to pay the required rent on his National Park Service government housing unit, the value of the required rent being less than \$1,000.

In violation of Title 18 United States Code § 654, a misdemeanor level offense.

being an officer, employee or agent of the United States or of any department or agency thereof, having received public money, to wit, National Park Service change of duty relocation funds not exceeding \$1,000. which he was not authorized to retain as salary, pay, or emolument, did knowingly fail to render his accounts for the same as provided by law.

In violation of Title 18 United States Code § 643, a misdemeanor level offense.

## (Accounting Generally for Public Money)

In or about October 2018 through September 2019, on St. Croix, in the District of the Virgin Islands, the defendant,

#### GREGORY CAMACHO,

being an officer, employee or agent of the United States or of any department or agency thereof, having received public money, to wit, National Park Service funds from overlapping travel reimbursements not exceeding \$1,000, which he was not authorized to retain as salary, pay, or emolument, did knowingly fail to render his accounts for the same as provided by law.

In violation of Title 18 United States Code § 643, a misdemeanor level offense.
