As a result of its review of the USPS ethics program, the Office of Government Ethics (OGE) issued six recommendations in its August 2023 inspection report. OGE conducted a follow-up review to assess whether the USPS has taken sufficient action to resolve the deficiencies underlying these recommendations. The results of the follow-up review are summarized below.

OGE Finding: USPS OIG's written procedures for collection, and review/evaluation of OIG confidential reports met applicable requirements.	Closed
3	Ensure USPS OIG new entrant confidential reports are filed timely.	OGE examined 19 USPS OIG new entrant confidential financial reports filed in 2022 during its 2023 inspection and found that 10 or (53%) were filed timely.  OGE Finding: In November 2024, OGE reviewed 15 USPS OIG new entrant confidential financial disclosure reports filed in 2024. Of these reports, 14 (93%) were filed timely.	Closed
4	Ensure notices to new prospective USPS OIG employees contain contact information of the ethics office or an explanation on how to obtain additional information.	OGE Finding: Notices to new prospective USPS OIG employees contained the required compliance language.	Closed
